An exciting opportunity has arisen for an **Intellectual Property Lawyer** to join Toyota Motor Corporation Australia (Toyota Australia) in a full-time permanent role.

The Intellectual Property Lawyer role is primarily responsible for supporting with the protection of Toyota Australia's intellectual property rights in respect of parts and accessories as well as repair and collision services. This includes:

- (1) Trade mark and copyright infringement with particular focus on counterfeit Toyota parts and accessories sales;
- (2) Passing off; and/or
- (3) Contravention of Australian Consumer Law.

This role is primarily based at the Toyota Centre of Excellence in Altona North with flexible work arrangements.

How you'll make an impact

- Manage intellectual property infringement cases by maintaining case management records, handling cases from start to finish, including conducting initial desktop enquiries to ensure cases are progressed and resolved in a timely manner.
- Manage Toyota online monitoring system for trade marks protection.
- Complete monthly reports in relation to Team's KPIS and drafts bulletins and presentations for TMCA and Dealers.
- Manages evidence and investigations by conducting trap purchases by liaising with investigators and ensuring evidence is adequately verified and stored.
- Provide day-to-day legal and operational support to the Aftersales Division in respect of parallel imports. This includes coordinating a global working group, hosting and facilitating meetings, drafting documents and presentations.
- Manage cases in relation to dealer agreement breaches in respect of the sale of parts and accessories as well as Parts Policy and Procedure Manuals. This includes, investigations, conducting regular audits of dealer compliance, maintaining tracking documents of dealer breaches, escalating potential breaches in a timely manner and following up until resolved.
- Conduct training to TMCA suppliers, and Australian Border Force officers. Training will be provided.
- Support the creation of non-genuine awareness for the public.
